

The changes have been made to the proposed rule to address comments made by the Joint Administrative Procedures Committee and to correct inadvertent errors in reference to forms contained in the rule.

Paragraph (4)(m) of Rule 25-30.445 is changed as follows:

(m) If the limited proceeding is being requested to change the current rate structure, provide a copy of all workpapers and calculations used to calculate requested rates and allocations between each customer class. The test year should be the most
