In response to the enclosed legal notice I received on 12/16/03 from the Colinas Group-Receivers.

When the Colinas group was appointed receivers they raised our water three times the amount we had been paying. We were told that the system was going to be improved. As of this date this property owner has not seen this.

On 12/13/03 I received a phone call that two of the residents did not have water. They gave us an after hours number to call, it is an answering machine that does not return the calls. On 12/15/03 in the late afternoon, when I finally was able to contact Mr. Freed and informed him that four or five families only had a trickle of water and told him there was a line busted. And water was running on the ground. The busted line was not repaired until 12/19/03 and many phone calls later, I was told they would repair it but they didn't have the equipment or know how. All this time the water was running. And children could not bath or go to school.

Why should they be allowed to operate a utility without proper knowledge or equipment. Why not Lakeland Water which supplies to the MASTER METER. Or the State which let this mess be created for years. With this being a private owned utility there is no one to over see it, or no one to regulate it.
