

Dear Mr. Pratico:

On December 8, 2003, the Commission received your letter dated December 5<sup>th</sup> requesting cancellation of your pay telephone certificate. Before staff can recommend a voluntary cancellation of a certificate, a company must be in good standing. According to our records, the company has a \$6.00 balance for late payment of the 2002 Regulatory Assessment Fee and the 2003 fee has not yet been paid. As information, there is a \$50 minimum even if a company never starts operations. The 2003 Regulatory Assessment Fee return form and a breakdown of the 2002 balance are attached.


