Dear Ms. Gentry:

The Commission received your letter requesting cancellation of Adelphia's "CLEC portion of our certificate #5263..." Before a docket is established, I need to know what type of cancellation you are requesting and make sure that the correct certificate is cancelled. As you know Adelphia holds several certificates for CLEC authority. They are:

TA003 in the name of Adelphia Business Solutions of Jacksonville, Inc. d/b/a TelCove

TA004 in the name of Adelphia Business Solutions of Florida, Inc.

TX180 in the name of Adelphia Telecommunications of Florida, Inc.

TX278 in the name of Adelphia Business Solutions Investment, LLC d/b/a TelCove

Although I believe you are requesting cancellation of the TX180, which is in the same name as the IXC Certificate you mentioned in your letter, I need clarification.

In addition, there are two types of cancellation. One is voluntary. In that case, the company must be in good standing and not owe any Regulatory Assessment Fee. All of the Adelphia certificates (the four above and the three IXC certificates) owe the 2003 fee (due by January 30, 2004). If staff is to recommend voluntary cancellation, the fee must be paid.

The other type of cancellation is a bankruptcy cancellation. Since Adelphia has filed for Chapter 11 bankruptcy, the company can request a bankruptcy cancellation by writing another letter to the Commission, state that the company does not provide competitive local exchange service in Florida, and request that any unpaid fees be written-off.

Please review this information and let me know how the company wishes to proceed. A docket will not be opened until I hear back from you. Thanks.
