

Representative**



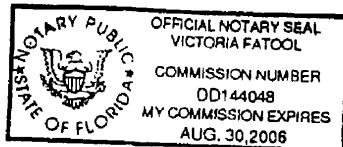
