<u>RECOMMENDATION</u>: The Commission should accept the company's settlement proposal. Any contribution should be received by the Commission within 14 calendar days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Florida Department of Financial Services for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, Certificate No. 7737 should be cancelled administratively. If Kernan Associates, Ltd. d/b/a St. Johns Estates' certificate is cancelled in accordance with the Commission's Order from this recommendation, the company should be required to immediately cease and desist providing competitive local exchange telecommunications service in Florida.


