By Order No. PSC-03-0792-FOF-WU, issued July 3, 2003, in Docket No. 030453-WU, the Commission approved the name correction of your utility from Countywide Utility Company to County-Wide Utility Co., Inc. The order also required you to file a revised tariff reflecting the utility's corrected name and to return Certificate No. 390-W. Please prepare and file a revised tariff with the correct name of the utility on each page. A copy of the Commissions model tariff maybe used. See the Commission website at www.floridapsc.com. Click on the water and wastewater icon, water and wastewater application packages, and the model water tariff. Also, please return Certificate No. 390-W. A new certificate will be issued in the corrected name of the utility.

In addition, it has come to our attention that County-Wide Utility Co., Inc. and the City of Ocala have entered into an agreement to provide service to the West Wind subdivision project. According to the City of Ocala, the development is not in your service area. Based on our research. the West Wind project is a mixed-used development of residential, commercial and professional areas at Southwest 60th Avenue and State Road 200. It appears that West Wind development is not in your service area. Enclosed are copies of Commission Order Nos. 11868 and PSC-97-0578-FOF-WU which authorized County-Wide Utility Co., Inc. to provide water service. Please provide a territory description using section, township, and range of the West Wind development that you are proposing to serve. Attached please find "Instructions for Preparation of Territory Description and Map".

As we discussed on January 22, 2004, your current certificate only allows you to provide water service. If you are going to provide wastewater service to the West Wind service area, you need to obtain a wastewater certificate before you provide service to the area.
