I am writing to request that the Florida Public Service Commission grant my client intervenor status in the certification of Island Environmental Utility, Inc., wastewater docket no. 020745-SU.

The granting of this certificate would directly effect my client's interests, as all the members of the Association are property owners in the proposed service territory.

They object to certification of this utility company because the issuance of a certificate to Island Environmental, Inc., violates an established local comprehensive plan policy, Infrastructure Policy 9.1.4, developed pursuant to Section 163.3161-163.3211, Florida Statutes. This policy prohibits the expansion of sanitary sewer service outside of County's Infill Area boundaries.
