



The Commission received your letter dated December 30, 2003, requesting cancellation of Big Planet's IXC certificate effective January 1, 2004. Before staff can recommend voluntary cancellation of a certificate, a company must leave in good standing. In this case, our records show that the company has a \$14.81 balance for late payment of the 2001 Regulatory Assessment Fee. In addition, the 2003 fee, which is due by January 30, 2004, has not been paid. These will need to be taken care of before a docket can be established.
