

1. On February 17, 2004, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the Sebastian exchange (Main), along with Attachments 1, 2, and 3. Attachments 1, 2, and 3 contain information that is considered confidential and proprietary to BellSouth. A Notice of Intent to Request Specified Confidential Classification for these attachments was also filed on the same day.

4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.


