CSX TRANSPORTATION'S AGREED AND UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE TESTIMONY OF JOHN B. STAMBERG AND ROBERT L. SANSON

CSX Transportation ("CSXT"), pursuant to Rule 28-106.204, Florida Administrative Code, hereby files this request for a one-day extension of time to file the testimony of witnesses John B. Stamberg and Robert L. Sansom in this docket and in support thereof states as follows.

1. CSXT is an intervenor in this docket. The deadline for intervenors to file testimony is March 29, 2004.

2. CSXT and Tampa Electric Company ("TECO") have entered into a non-disclosure agreement concerning the treatment of confidential, proprietary business information exchanged in this case.

3. CSXT on this date filed and served, in redacted format, the testimony of Robert F. White.

4. CSXT was also prepared to file today the testimony of its other two witnesses, John B. Stamberg, P.E., and Robert L. Sansom, Ph.D.; however, Mr. Stamberg's and Dr. Sansom's testimony contains certain information that is confidential, proprietary business information for both TECO and CSXT.

CSXT will also provide TECO for its review, a draft of Mr. Stamberg's testimony, similarly marked, by 5:00 p.m. today.




