

**PETITION FOR APPROVAL OF ENVIRONMENTAL COST RECOVERY
TRUE-UP FOR THE PERIOD ENDING DECEMBER 2003**

Florida Power & Light Company ("FPL") hereby petitions this Commission for approval of FPL's actual End-of-Period Environmental Cost Recovery Clause ("ECRC") true-up over-recovery amount of \$894,810 for the period January 2003 through December 2003 and an over-recovery of \$43,877 as the adjusted net true-up amount for the same period. In support of this Petition, FPL states as follows:

1. The actual End-of-Period ECRC true-up over-recovery of \$894,810 for the period January 2003 through December 2003 was calculated in accordance with the methodology set forth in Schedule A-2 for the Fuel Cost Recovery Clause, attached to Order 10093 dated June 19, 1981. This calculation and the supporting documentation are contained in the prepared testimony of FPL witness K.M. Dubin, which is being filed together with the Petition and incorporated herein.

2. In Order No. PSC-03-1348-FOF-EI, dated November 25, 2003, the Commission approved an over-recovery of \$850,933 as the estimated/actual ECRC true-up for the period January 2003 through December 2003.

3. The adjusted net true-up for the period January 2003 through December 2003 is an over-recovery of \$43,877, which is the difference between the actual true-up over-recovery of \$894,810 and the estimated/actual true-up over-recovery of \$850,933.


WHEREFORE, Florida Power & Light Company respectfully requests the Commission to approve an actual End-of-Period Environmental Cost Recovery true-up over-recovery amount of \$894,810, and an over-recovery of \$43,877 as the adjusted net true-up, for the period January 2003 through December 2003.


