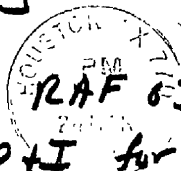

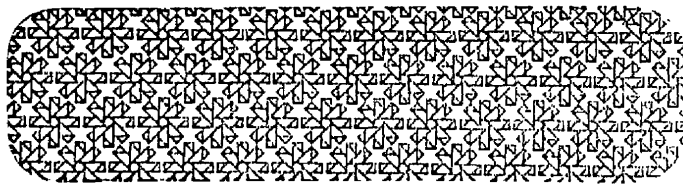

Dear Mr. McConaty:

I wrote you a letter on February 11, 2004, explaining that the Commission had received the company's 2003 Regulatory Assessment Fee return, but that the minimum \$50 fee, plus penalty and interest charges, was not included. In addition, I advised if the company was requesting cancellation of its certificate, it needed to write a letter requesting cancellation and pay the 2004 fee also. As of this date, the Commission has not received payment or a response.

To avoid a possible enforcement docket from being established that normally carries a \$500 fine, please mail your check for \$106 (\$50 fee for each year -- 2003 and 2004, \$5 penalty, and \$1 interest), along with a letter requesting cancellation by March 30th. The penalty and interest charges continue to accrue until the fee is paid.

Dear Mr. McConaty:

On February 9, 2004, the Commission received the company's 2003 Regulatory Assessment Fee return form showing zero revenues, along with a note advising the company is out of business and had withdrawn from Florida in 2003. Payment of the \$50 minimum Regulatory Assessment Fee was not included.

The Regulatory Assessment Fee is assessed if a certificate is active for any one day during a calendar year, even if a company had no revenues or ever started operations during the period covered. The 2003 Regulatory Assessment Fee was due by January 30, 2004. Since payment was not included with your return, statutory late payment charges are now applicable.

I researched our records, but could not find record that you had previously requested cancellation of your CLEC certificate from the Commission. A copy of the cancellation rule is enclosed. This means that since you did not request cancellation of your certificate in 2003, C2C Fiber of Florida, Inc. owes the 2004 Regulatory Assessment Fee in addition to the 2003 fee.

If you want to cancel C2C Fiber of Florida, Inc.'s CLEC certificate, you need to write the Commission a letter and specifically request cancellation in compliance with Rule 25-24.820, Florida Administrative Code. Your letter should include payment of the minimum \$50.00 2003 fee, the \$3.00 late payment charges (if postmarked by February 29th), and a copy of the completed 2003 Regulatory Assessment Fee return form. In addition, since your certificate is still active in 2004, you also owe the 2004 fee. The 2004 return form is enclosed, which needs to be completed and returned with the \$50 minimum payment. The total due is \$103, if payment is postmarked by February 29, 2004. When returning payment and the above information, please use the enclosed blue envelope, which will insure prompt processing.

(1) The Commission may on its own motion, after notice and opportunity for hearing, revoke a company's certificate for any of the following reasons:

- (a) Violation of a term or condition under which the authority was originally granted;
- (b) Violation of Commission rule or order;
- (c) Violation of Florida Statute; or
- (d) Violation of a price list standard.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request. Cancellation of a certificate shall be ordered subject to the holder providing the required information.

- (a) A statement of intent and date certain to pay regulatory assessment fee.
- (b) A statement of why the certificate is proposed to be canceled.
- (c) A statement as to how customer deposits and final bills will be handled.
- (d) Proof of individual customer notice regarding discontinuance of service.
