I have received your letter dated March 27th regarding the cancellation of D'aroc Corporation Inc.'s pay telephone certificate.

In order to process the cancellation in good standing, the 2003 and 2004 minimum regulatory assessment fees will need to be remitted for the company. The minimum Regulatory Assessment Fee is \$50 and penalties and interest will apply to the 2003 minimum fee as it was due 1/30/2004.


