This firm is general counsel to Source One Communications, Inc. You are a Company dealer operating in Marianna, Florida. The Company has instructed us to file suit to protect its interest, and those of its customers.

It has come to the Company's attention that you may be transferring Source One's customers to a competing local exchange company. If so, these transfers have occurred without the knowledge or consent of Source One Communications, Inc. Further, we believe this has occurred without the knowledge or consent of Source One's customers, and therefore, may constitute "Slamming," a violation of Florida Law.

As a Source One dealer you are its agent, with a duty to sign up customers, collect, and remit funds. Your actions constitute a breach of that duty. On behalf of Source One, we will seek damages to recover, among other things, lost profits from transferred customers, as well as attorney's fees and costs. In addition, to the extent that you have collected any payments from Source One's customers which are neither turned over to Source One nor returned to such customers, we will sue for recovery of such funds. Further, it is the Company's policy to turn records over to local law enforcement authorities to pursue any criminal action which may be warranted.


