A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF OKEECHOBEE COUNTY, FLORIDA; INVOKING THE JURISDICTION OF THE FLORIDA PUBLIC SERVICE COMMISSION OVER NON-GOVERNMENTAL WATER AND SEWER UTILITIES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Okeechobee County is a non-jurisdictional county for purposes of public service commission regulation of water and sewer utilities; and

WHEREAS, Chapter 367, Florida Statutes, provides a procedure by which a County may invoke the jurisdiction of the Public Service Commission for a period of not less than ten (10) years; and

WHEREAS, growth in Okeechobee has reached the point that regulation of non-governmental water and sewer utilities is necessary; and

WHEREAS, specialized expertise and procedures are necessary to adequately and fairly evaluate tariffs for water and sewer utilities.

NOW THEREFORE IT BE RESOLVED by the Board of County Commissioners of Okeechobee County as follows:

- 1. THAT pursuant to Section 367.171, Florida Statutes, Okeechobee County hereby invokes the iurisdiction of the Florida Public Service Commission.
- 2. THAT the County Administrator shall immediately notify the Florida Public Service Commission of this Resolution and provide a certified copy to the Commission.
- THAT the County Administrator shall forthwith forward to the Florida Public Service Commission any pending complaints against a water or sewer utility located in Okeechobee County, Florida.
- 4. THAT this resolution shall be effective upon adoption.
