
1. On April 27, 2004, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX-X Code Denial for the Jacksonville exchange (Beachwood), along with Attachments 1 and 2. Attachments 1 and 2 contain information that is considered confidential and proprietary to BellSouth. A Notice of Intent to Request Specified Confidential Classification for these attachments was also filed on the same day.

Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification for Attachments 1 and 2 because said attachments contain switch utilization information that is considered confidential and proprietary to BellSouth.
