Dear Ms. Longnecker:

On April 14, 2004, the Commission received your letter dated April 2, 2004 requesting cancellation of the company's IXC and CLEC certificates in Florida with an effective date of June 1, 2004. Before staff can recommend voluntary cancellation, a company must not have any outstanding Regulatory Assessment Fees. Commission records show that the company owes \$6 for late payment of the 1999 and 2003 fees on its IXC certificate and \$3 for late payment of the 2003 fee on its CLEC certificate, for a total of \$9. Breakdowns are attached.

In addition, the company must either pay the 2004 Regulatory Assessment Fees on both certificates or provide a date certain the fees will be paid. Since your letter stated the company still had a few IXC customers in Florida, the company will not be able to go ahead and pay the IXC fee. However, I'm enclosing the 2004 Regulatory Assessment Fee return forms for both certificates. You may just want to follow up your April 2nd letter with another letter and state that the 2004 Regulatory Assessment Fees will be paid within 30 days after issuance of the Order granting the voluntary cancellations.

Due to the significant changes in the telecommunications marketplace, RCN made a change in the company's overall strategy to focus activities in its facility-based areas. As a part of our continuing effort to make the Company's network more efficient, RCN has made a business decision not to begin providing Competitive Local Exchange Services and to discontinue providing Interexchange Long Distance services in the state of Florida.

RCN currently has no Local Exchange customers and 18 Interexchange Long Distance customers in Florida. In compliance with all requirements under applicable law, RCN is providing customers with 60 days notice to secure service from another provider. Attached is a copy of the notification that customers will be receiving. Thirty days prior to discontinuance, RCN will send a reminder letter if the customer has not yet changed to a new service provider.

RCN respectfully submits an original and six (6) copies of this letter to request cancellation of its Competitive Local Exchange Carrier and Interexchange CPCNs (000683-TX, Order No. PSC-00-1218-PAA-TX) and cancellation of the current tariffs on file. We are further requesting that the cancellation to be given an effective date of June 1, 2004.
