## Dear Sir/Madam:

Please be advised that this firm represents the CTC Litigation Trust (the "Trust"). As you may know, the Trust was established pursuant to the Second Amended Joint Plan of Reorganization (dated November 20, 2003) (the "Plan") filed by CTC Communications Group, Inc. and related entities (collectively, the "Debtors"). Under the Plan, the Trust is authorized, among other things, to resolve, liquidate and realize upon certain assets as the successor to and representative of the Debtors' estates. These assets include, without limitation, certain causes of action arising under Chapter 5 of the Bankruptcy Code and recovery of loans, advances or other amounts due from any of the Debtors' former employees, and all proceeds from and income earned on any of these assets (the "Retained Actions"). The Trust is administered by TRG Turnaround and Crisis Management ("TRG"), Stonehill Capital Management LLC and Relational Funding Corporation (collectively, the "Trustees").

The purpose of this letter is to inform you of the launching of the official Trust website at http://ctc.dsgoutsourcing.com (the "Website"). Specifically, the Website will provide, among other things, quarterly reports that will include updates on the Retained Actions and financial statements to beneficiaries of the Trust.
