Dear Ms. Bayo:

By letter dated May 4, 2004, we notified the Florida Public Service Commission ("Commission") that Adelphia Business Solutions, Inc. d/b/a TelCove ("TelCove"), the ultimate parent of Adelphia Business Solutions Investment, LLC d/b/a TelCove, emerged from bankruptcy and changed its name to TelCove, Inc. The letter also notified the Commission that as a result of the emergence from bankruptcy the name of the Florida operating entity, Adelphia Business Solutions Investment, LLC d/b/a TelCove, was changed to TelCove Investment, LLC. The letter also indicated that TelCove would make an official name change filing with the Commission as soon as TelCove received final documentation from the Florida Secretary of State.

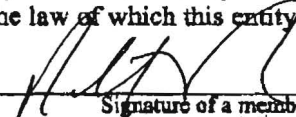
