#### JOINT STATUS REPORT

Progress Energy Florida, Inc. (Progress Energy) and Withlacoochee River Electric Cooperative, Inc. (WREC), pursuant to Order No. PSC-04-0339-PCO-EU granting Progress Energy's Agreed Upon Motion to Toll Time, file this Joint Status Report and state as follows.

The settlement negotiations described in the Agreed Upon Motion to Toll Time remain ongoing. In addition to the initial settlement meeting referred to in the Motion, Progress Energy and WREC have met on several subsequent occasions to pursue settlement opportunities. In preparation for and in follow-up after these meetings, the parties have also conducted field investigations and evaluations to identify areas suitable for the development of settlement alternatives.
