Accordingly, with this Memorandum, Docket No. 040462-TI is hereby closed.

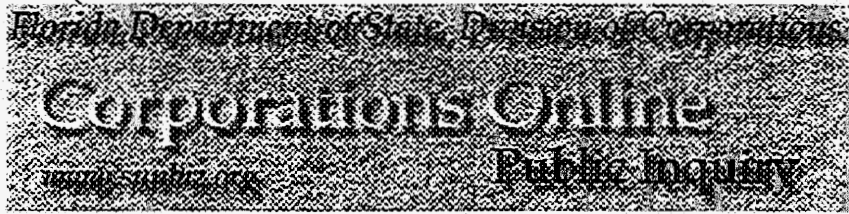

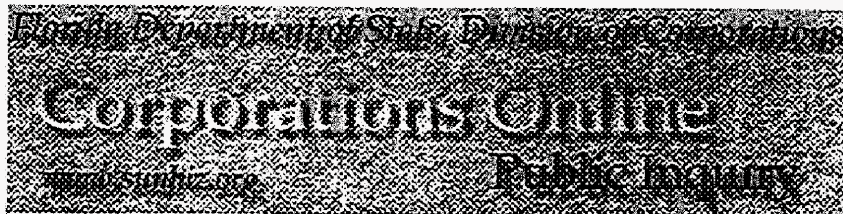
