RE: Docket No. 040353-TP - Informal Extension of Time

Dear Commissioner Bradley, Pre-hearing Officer:

On May 27, 2004, the Florida Public Service Commission (FPSC) issued its Order To Initiate Expedited Discovery Procedure, Order No. PSC-04-0549-PCO-TP (the Order). This Order provided that "all discovery responses shall be due 10 calendar days after service of the request, with no additional time for mailing." On May 28, 2004, Supra timely filed its responses pursuant to the Order. When Supra did not receive BellSouth's timely filed responses as of June 7, 2004, Supra inquired to Staff whether BellSouth had responded. Supra was informed for the first time that BellSouth had "informally" requested, and received, an extension of time to provide discovery responses, as set forth in the formal Order, until Monday June 14, 2004. Supra requests that in the future, the parties be required to formally request any such extensions, and provide notice to the other party. Additionally, Supra similarly requests that any such granting of extensions be noticed and provided to both parties.
