Revised Tariff Sheet No. 3.1 I and page 6 of Exhibit "H" are being provided in response to Patti Daniel's letter dated June 2, 2004, in which the territory description that was submitted with Crooked Creek's Application was identified as a deficiency in that the description of Island 4 contained an error. We believe that the enclosed revised tariff sheet and exhibit page cure the identified error, and Crooked Creek's application should be deemed complete.

In addition to the deficiency noted above, Ms. Daniel's June 2, 2004 letter also contained a request for 2 additional items of information. Item 1 referred to a possible error contained in Tariff Sheet No. 22, and requested clarification as to whether it was an error. Crooked Creek filed its revised Tariff Sheet No. 22 on June 1, 2004, correcting the error.


