According to our records, Commercial Utilities, Division of Grace and Company, Inc. failed to timely file its 2003 Annual Report by April 30, 2004 or request an extension as required by Rule 25-30.110(3), Florida Administrative Code (F.A.C.). Rule 25-30.110(6) and (7), F.A.C., sets penalties for noncompliance with the annual report requirement. The applicable penalty for a Class B utility is \$13.50 per day and is based on the number of calendar days elapsed from the due date until the date of filing.
