Dear Sir or Madam:

Chapter 364, Florida Statutes, contains the framework the Commission uses for regulation of the telecommunications industry. As a result of certain amendments made to the chapter during the 1995 legislative session, the Commission has a statutory mandate to prepare and deliver annually a report, to the Governor and the Legislature, on the status of competition in the telecommunications industry.

In order to meet this legislative mandate we must gather data from the industry. The enclosed data request will help us evaluate the status of local competition in Florida. If your company holds a certificate but is <u>not currently active</u> in the marketplace, you may simply check the box at the top of this page and return it. However, please note that there are other sections of the data request to which you may respond, such as comments you may have regarding Florida's marketplace and entry barriers.

We have made several changes to the data request this year as part of our ongoing commitment to increase efficiency and reduce CLEC reporting burden:

- The "as of" date for data is now May 31, 2004 NOT June 30, 2004.
- Responses are due to the Commission by July 15, 2004. This provides you with an additional two weeks of response time compared to previous years.

We ask for information on Voice over Internet Protocol (VoIP).

• We have substantially revised the data tables, e.g., the structure and format have changed, and we no longer ask for information by wire center or zone.

Many CLECs have told us of their difficulty in obtaining exchange level data. We still
require information by exchange, but we have added more detailed instructions to show you
how data by exchange may be obtained from your records. Staff is also available to consult with
you.

We have added sample tables to aid you in completing your responses.

• The data request and data table files are in Word and Excel, respectively, and are available for downloading at our website: <a href="http://www.psc.state.fl.us/RandR/LCDR">http://www.psc.state.fl.us/RandR/LCDR</a>. The CLEC files are named CLEC data request.doc and CLEC data tables.xls. We request that you provide your response on a CD or diskette using Word for the written responses and Excel for the data tables.

Once the completed data request is received by the Commission, the information will be public record. If you believe your response to the data request contains confidential information, you can request that the confidential information be exempt from FS 119.07(1), General State Policy on Public Records. Enclosed is a copy of Florida Public Service Commission Rule 25-22.006, Florida Administrative Code, which provides the necessary information for submitting confidential information to be exempt from FS 119.07(1). Please note that a claim of confidentiality does not alleviate the obligation to respond to the data request in a timely manner. In addition, claims of confidentiality should not be made for information that is publicly available from other sources (switch locations, for example, are available from the Local Exchange Routing Guide).

In order to meet our statutory obligations, it is essential that we obtain this information in a timely manner, as required by Florida Public Service Commission Rule 25-4.043, Florida Administrative Code, Response to Commission Staff Inquiries. Failure to comply with this rule can result in the Commission assessing penalties of up to \$25,000 per offense, with each day of non-compliance constituting a separate offense per FS 364.285(1). We encourage retaining a record confirming delivery of your company's response to the data request, such as a certified mail receipt, a fax log or a copy of an e-mail.

Responses to the enclosed data request are due no later than July 15, 2004. We request that you provide your response on a CD or diskette using Word for the written responses and Excel for the data tables.
