Dear Mrs. Bayó:

In a Memorandum dated October 24, 1997, the Florida Public Service Commission ("Commission"), requested BellSouth to begin reporting slamming data on a monthly basis to include the number of consumer contacts to the company related to each carrier (name & CIC), whether the slam is interLATA, intraLATA or both and the number of local slamming contacts.

BellSouth considers the above information provided in this response to be proprietary and requests appropriate treatment thereof pursuant to 364.183(1), Florida Statutes and Rule 25-22.006(5), Florida Administrative Code. This information includes customer specific information.


