

Dear Ms. Gershfeld:

In 2001, the Florida Public Service Commission was notified that Telecom Consultants, Inc., which included North American Telecommunications Corporation d/b/a Southeast Telephone Company (NATC), had filed for Chapter 11 bankruptcy protection (Case No. 01 B 10907(RDD) - Jointly Administered). On February 7, 2002, the Commission received notice that the Chapter 11 bankruptcy case had been converted to a Chapter 7 case.

If the company no longer has need of its interexchange and competitive local exchange company certificates in Florida, can you request cancellation of the certificates and ask that any unpaid Regulatory Assessment Fees be written off? Staff will then open a docket and recommend to the Commission that the company be granted a cancellation of its certificates due to the bankruptcy and request permission to write off the 2000, 2001, 2002, 2003, and 2004 Regulatory Assessment Fees, including statutory late payment charges.
