Thank you for your correspondence regarding the application filed in the above-referenced docket. In your letter, you indicated that you object to any increase in the utility's rates. Please be advised that The Colinas Group **has** not requested an increase to the flat rate of \$35.50 that you are currently charged per month. The utility has filed an application for a certificate of authorization from the Public Service Commission in order to continue to provide service as the receiver for **Lazy S Utility Co.**

The Commission needs to know your intent regarding your objection to this **application**. If you choose to pursue the objection, you may request a formal hearing, which will be scheduled and at which you will be required to provide testimony and other evidence to support your protest. Although the Commission allows individuals to represent themselves at hearing, you may wish to hire an attorney to represent you.


