
Dear Ms. Bayo,



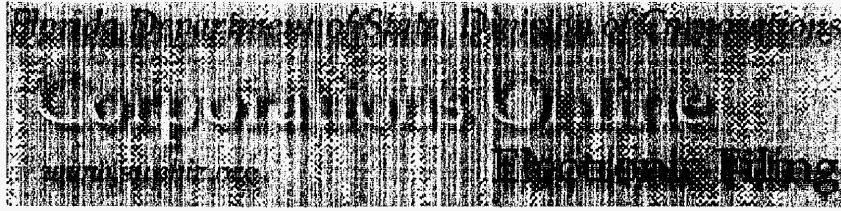
