BellSouth Telecommunications, Inc. ("BellSouth"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification and states the following:

1. On June 3, 2004, the Florida Public Service Commission (hereinafter "Commission"), requested that BellSouth provide certain information to help the Commission evaluate the status of local competition in Florida. This information is being provided in connection with the Commission's request.


