Deficiency

Territory description: Pursuant to Rule 25-30.033(1)(I), the applicant is to provide a description of the territory to be served, using township, range and section references as specified in subsection 25-30.030(2), Florida Administrative Code. The territory description that was submitted with the application has an error in it involving Island No. 4.

Additional Information

1. Please refer to Wastewater original sheet no. 22.0 under the heading "Developer Contributions". The policy refers to the water distribution system, is this an error or will the utility have developer agreements for the wastewater system?
2. Please submit Original Sheet No. 20.0 with a copy of the customer's bill.
