**BELLSOUTH TELECOMMUNICATIONS, INC.'S
MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant BellSouth a seven day extension of time in which to file Objections and Responses to Supra Telecommunications & Information Systems, Inc ("Supra") Requests to BellSouth. In support of this motion, BellSouth states the following:

1. Supra served it's Second Request for Admissions (Nos. 18-31) to BellSouth on July 15, 2004. Pursuant to Order No. PSC-04-0459-PCO-TP ("Procedural Order"), objections to these Admissions are due July 22, 2004 and Responses are due on July 26, 2004.

2. Supra served it's Third Set of Interrogatories (Nos. 28-30) and Third Request for Production (Nos. 17-18) to BellSouth on July 16, 2004. Objections to this discovery are due July 23, 2004 and responses are due July 26, 2004.

3. Because of undersigned's travel schedule and work load, BellSouth requests an extension of time to file objections and responses to Supra's most recent set of discovery until July 30, 2004.

4. No party would be prejudiced by this brief extension of time because no hearing date or testimony deadline date has been established in this docket. Further,

because of the expedited discovery deadlines established in the Procedural Order, even with the extension, Supra will receive responses to its discovery approximately two weeks prior to when they would otherwise be due.


5. BellSouth attempted to contact counsel for Supra to ascertain Supra's position regarding BellSouth's request. BellSouth was unable to obtain a response prior to the filing of this Motion.
