
Dear Ms. Bayó:

Both of the dockets listed above involve requests filed by competitive local exchange carriers ("CLECs") seeking orders requiring BellSouth to honor its existing interconnection obligations. In both dockets, BellSouth responded by filing a motion to dismiss in which it explained in detail that the relief requested by the CLECs was unnecessary.

While an order dismissing these dockets remains an appropriate outcome, BellSouth is agreeable to an alternative outcome; namely, an order in which the Commission would hold these dockets in abeyance pending the issuance of interim FCC rules. BellSouth has no objection to such an order being issued prior to the Commission ruling on its motions to dismiss.




