This letter is in response to the requests of Katherine Fleming and Pat Brady for additional information relating to the Amended Second Motion for Extension of Time of Ocala Springs Utilities Inc. ("the Motion") which was filed in this docket on March 25, 2004.

The financial and technical ability of Ocala Springs Utilities Inc. ("OSUI") to provide service has not changed since the granting of OSUI's application for original water and wastewater certificates by Order No. PSC-98-1644-FOF-WS, issued December 7, 1998. OSUI's parent company, Avatar Utilities, promises to finance the initial operation of the utility. Specifically, the construction funds for any water and wastewater facilities would be funded by Avatar Holdings Inc., the parent company of Avatar Utilities Inc. Further, OSUI has the technical knowledge and ability to operate the utility through the experience of Avatar Utilities which provided water and wastewater service through its subsidiaries from 1956 until the transfer of Florida Cities Water Company to a governmental authority in 1999.
