**RE:** Docket No. 040804-TL, Petition for Expedited Review of Growth Code Denial by the Number Pooling Administrator for the Miami Exchange (Silver Oaks), by BellSouth Telecommunications, Inc.

On July 30, 2004, BellSouth filed a petition requesting that the Commission overturn NeuStar's decision to deny numbering resources for the Silver Oaks switch (MIAMIFLSODS0) located in the Miami rate center. In accordance with Commission Order PSC-02-0352-PAA-TL, which approved an expedited process for code denials, we have examined the BellSouth petition, along with the confidential supplemental information, and have determined the following:

- 1) The carrier has demonstrated that it has a customer in need of immediate numbering resources;
- 2) The carrier has shown that it will be unable to provide services to a potential customer because of the Pooling Administrator's denial of the numbering resources; and
- 3) A potential customer cannot obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three required criteria of Order PSC-02-0352-PAA-TI, have been met, please prepare an administrative Proposed Agency Action (PAA) Order to be issued within seven business days of this memorandum (August 18, 2004) as outlined in the expedited code denial process order. NeuStar should be directed to provide BellSouth the needed (4) 1,000 consecutive number blocks in the format of 786-NX4-6-9 to meet a request of a specific customer in the Miami rate center (Silver Oaks). Also, please allow staff assigned to the docket to review the Order before it is issued. If you have any questions, please call Bob Casey at 413-6974.
