- 3. "Petitioner" or "Petitioners" shall mean Petitioners Ocean Properties, J.C. Penney, Dillard's and Target, individually or collectively, and any attorney, employee, agent, representative, or other person acting or purporting to act on such Customer(s) behalf in Florida Public Service Commission Docket No. 030623-EI.
- 4. "Person" or "persons" means all natural persons and entities, including but not limited to: corporations, companies, partnerships, limited partnerships, joint ventures, trusts, estates, associations, public agencies, departments, bureaus, or boards.
- 5. "Document or documents" means "documents" as defined in Rule 1.350 of the Florida Rules of Civil Procedure. - 3. All documents exchanged between: (a) you and SUSI related to methods or means of reducing the amount of FPL electric bills and (b) you and Bill Smith related to methods or means of reducing the amount of FPL electric bills.
- 4. All documents exchanged between: (a) you and SUSI related to your electric account, meter, electric consumption, or usage and (b) you and Bill Smith related to your electric account, meter, electric consumption, or usage.
- 5. All documents related to how SUSI is compensated or proposed to be compensated for any and all services performed or proposed to be performed by SUSI for you.
- 6. All documents related to how Bill Smith is compensated or proposed to be compensated for any and all services performed or proposed to be performed by Bill Smith for you.
