

BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), pursuant to Rule 25-22.006, Florida Administrative Code, files this Request for Specified Confidential Classification and states the following:

1. On July 27, 2004, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the DeLand exchange (Miami), along with Attachments 1 and 2. Attachments 1 and 2 contain information that is considered confidential and proprietary to BellSouth. A Notice of Intent to Request Specified Confidential Classification for those attachments was also filed on the same day.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification for Attachments 1 and 2 because said attachments contain switch utilization information that is considered confidential and proprietary to BellSouth. 3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.
