1. On July 30, 2004, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the Miami exchange (Silver Oaks), along with Attachments 1 and 2. Attachments 1 and 2 contain information that is considered confidential and proprietary to BellSouth. 3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.


5. Appended hereto as Attachment C is a sealed envelope containing one copy of the documents including the material which is confidential and proprietary.
