

**AMENDED JOINT
MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the Parties a one (1) day extension of time or until August 17, 2004, in which to file their Prehearing Statements. In support of this motion, BellSouth states the following:

1. On December 30, 2003, IDS filed an *Amended* Complaint for Overbilling and Discontinuance of Service and Petition for Emergency Order Restoring Service in the captioned docket. The Commission issued Order No. PSC-04-0423-TOT-TP on April 26, 2004 granting BellSouth's Partial Motion to Dismiss part of IDS's Amended Complaint. The Commission issued Order No. PSC-04-0625-PCO-TP – Order Modifying Order Establishing Procedure ("Order"). In this Order, the Commission established that Prehearing Statements would be due August 16, 2004.

2. Due to other work commitments, BellSouth needs additional time to prepare its Prehearing Statement.

3. The Parties would not be prejudiced by a one (1) day extension of time.

4. BellSouth has contacted counsel for IDS to ascertain IDS' position as to BellSouth's request. IDS informed BellSouth that it does not object to BellSouth's request for an extension of time.


