Residential and Business customers required to temporarily relocate to a new location during the repair or reconstruction of their existing premises due to damages caused by Hurricane Charley are entitled to the following waivers: 1) The waiver of nonrecurring Service Connection Charges when establishing temporary service at a new location; and 2) The waiver of the monthly recurring charges when placing their existing service on Vacation Service while waiting for the repair or reconnection of their existing premises.

These waivers are in addition to the current tariff which allows for the waiver of all Service Connection Charges incurred when re-establishing service at the former location caused by a natural disaster.

Acknowledgment, date of receipt, and authority number of this filing are respectfully requested. A duplicate letter of transmittal is attached for this purpose.
