COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, and files this Corrected Request for Specified Confidential Classification.

1. On July 29, 2004, BellSouth filed its Response to the Florida Public Service Commission Staff's data request in connection with the proposed rule changes in the captioned docket. The attachments to BellSouth's response to the Florida Public Service Commission Staff's data request contain confidential business information. Because portions of the attachments to BellSouth's response to the Florida Public Service Commission Staff's data request contain confidential business, proprietary information, BellSouth also filed a Notice of Intent on July 29, 2004.
2. On August 19, 2004, BellSouth filed its Request for Specified Confidential Classification. Upon review, BellSouth determined a more specific description of the location of the proprietary information needed to be provided in Attachment A, and is hereby filing a Corrected Request for Specified Confidential Classification.
3. These items should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e), Florida Statutes and is exempt from the Open Records Act.
4. Attachment B to BellSouth's Request for Confidential Classification is redacted copies of the documents containing the confidential information.

5. Attachment C to BellSouth's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.



**Explanation of Proprietary Information**

1. This information contains business information related to competitive interests of BellSouth that is proprietary to BellSouth. The documents contain actual unit cost information for discrete cost elements. Public disclosure of this information would provide BellSouth's competitors with an advantage in that they would know the price or rate below which BellSouth could not provide the service. The data is valuable to competitors and potential competitors in formulating strategic plans for entry, pricing, marketing, and overall business strategies concerning these services. This same information on competitors is not available to BellSouth. Disclosure of this data would impair the competitive business and cause harm to BellSouth. Consequently, this information should be classified as proprietary, confidential business information pursuant to Section 364.183, Florida Statutes and is exempt from the Open Records Act.
