On April 26, 2004, FPL filed a response to staff audit entitled: "FPL Fuel Cost Recovery Clause Audit for the Year Ended December 31, 2003", Audit Control No. 04-023-4-1, along with a notice of intent that FPL intended to seek a confidential classification for portions of the response to the audit.

On May 17, 2004, FPL filed its request for confidential classification for this audit response. FPL's request included a redacted copy for public use (Document 05636-04, Exhibit B) and a copy of the response with the sensitive information highlighted (Document 05637-04).

On August 9, 2004, after discussions with the staff, FPL reduced the amount of material requested for confidential treatment. This recommendation reflects that modification.

As part of their modified request, FPL asks that certain sensitive information which no longer supports their request for confidential treatment be removed from their filing.

Document 05636-04, Exhibit B, the redacted copy of FPL's filing, has already been released as a public file and therefore it is impractical to modify this document. Document 05637-04 is the copy of the audit report and working papers with all sensitive information highlighted which was submitted by FPL in support of its request for confidential treatment.
