To Whom it May Concern

Please be advised that as a result of a recent merger, Dominion Telecom has changed its name to Elantic Telecom, Inc. The address has changed to 2134 West Laburnum Avenue, Richmond, VA 23227. The Federal Employer Identification Number (FEIN) remains unchanged as 54-1861675.

On July 19, 2004, Elantic Telecom, Inc. (the "Debtor") filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code in the U.S. Bankruptcy Court for the Eastern District of Virginia, Richmond Division. The Debtor continues to operate its business as a debtor-in-possession pursuant to section 1107 and 1108 of the Bankruptcy Code.

As a result of the commencement of the Debtor's Chapter 11 case and by operation of law pursuant to Section 362 of the Bankruptcy Code, an automatic stay enjoins all persons and all governmental units from, among other things: (a) commencing or continuing any judicial, administrative or other proceeding against the Debtor that was or could have commenced before its Chapter 11 case was commenced, or to recover a claim against the Debtor that arose before the commencement of its Chapter 11 case; (b) taking any action to collect, assess, or recover a claim against the Debtor that arose before the commencement of its Chapter 11 case; and (c) taking any act to obtain possession of property of the Debtor or to exercise control over property of the Debtor.
