However, in light of the PSC's establishment of rate base in Docket No. 030891-WS, the source documents for the plant constructed prior to April 30, 2003, are unnecessary. Since May, 2004, Utilities, Inc. of Hutchinson Island has been attempting to obtain the schedules and source documents for all plant additions added by Columbia Properties Stuart, LLC. but as of this date, it has been unable to do so. We do expect to be able to obtain that
