PURPOSE: To permit parties to present testimony and exhibits relative to the petition to determine the need for the expansion of New Hope's Okeelanta cogeneration plant, whether to approve the associated power purchase agreement pursuant to which New Hope will sell seventy percent of the project's energy output to FPL, and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony on the issues identified by the parties at the prehearing conference held on October 4, 2004.
