This filing is to align US LEC's payphone surcharge with the recent FCC Report and Order, which revised Section 64.1301 of its rule. That rule states "In the absence of an agreement as required by paragraph (a) of this section, the carrier is obligated to compensate the payphone service provider at a per-call rate of \$0.494." US LEC is increasing its surcharge to the end user customer from \$0.30 to \$0.50.

Usage will be billed by US LEC to the Customer's US LEC account, broken out by individual user card number.
