**Section 8 - Surcharges and Fees**

- 8.1** The Company, at its discretion, will pass through the costs of any regulatory fees or assessments to the end user customer (such as Universal Service Fund, etc.), as allowed by law. (N)
- 8.2** **Cost Recovery Charge** - The Company will impose, at its discretion, a Cost Recovery Charge of \$0.81 to offset its costs incurred in complying with regulatory obligations imposed by state regulatory bodies. This charge is not a tax or fee imposed by a government entity.
- 8.3** **Bill Statement Fee** - The Company will charge a \$1.50 Bill Statement Fee on all calls which are billed to the customer's local exchange carrier bill (LEC bill). The customer will have the option of paying for the call by other means (credit card or coin), and therefore will not be charged the Bill Statement Fee on these types of calls. (N)
