On July 19, 2004, this Commission received information from Kelly Drye & Warren LLP on behalf of their clients, XO Florida, Inc., XO Communications Services, Inc. and Allegiance Telecom of Florida, Inc. On August 16, 2004, staff received contact information and name tabs from XO Communications Services, Inc. Staff has determined that the documents received meet the requirements of Section 364.02(13), Florida Statutes.

XO Communications Services, Inc. is now assigned TJ949 as its IXC Registration Code for the State of Florida. Pursuant to Section 364.02(13), Florida Statutes, IXCs must comply with Sections 364.04, Tariffs, 364.336, Regulatory Assessment Fees, 364.603, Carrier Selection Requirements, and 364.604, Billing Practices, Florida Statutes.

As required by Section 2.07.C.5.h, Administrative Procedures Manual, XO Communications Services, Inc. has provided the required contact information and tariff to be acknowledged as a registered intrastate interexchange telecommunications company effective August 17, 2004.

Further, on August 16, 2004, this Commission also received a request from XO Florida, Inc. for removal of XO Florida, Inc. from the IXC Registration List, effective August 17, 2004. Staff has determined that the company has paid 2004 regulatory assessment fees and any applicable penalties and interest as required in Section 364.336, Florida Statutes.

If XO Florida, Inc. commences operations in Florida as an IXC, a new registration must be filed.

As required by Section 2.07.C.5i, Administrative Procedures Manual, XO Florida, Inc., holder of IXC Registration No. TJ112, has paid the required regulatory assessment fees and can be removed from the IXC Registration list effective 08/17/2004.

Accordingly, with this Memorandum, Docket No. 040869-TI is hereby closed.
