The Commission should approve PGS's final PGA true-up amount of \$7,268,762 (underrecovery) for the period January 2003 through December 2003; its estimated PGA true-up amount of \$10,448,229 (overrecovery) for the period January - December 2004; and its levelized PGA (cap) factor of \$0.99037 per therm for the period January 1 through December 31, 2005. <u>ISSUE 1</u>: What are the appropriate final purchased gas adjustment true-up amounts for the period January 2003 through December 2003?

PGS: \$7,268,762 underrecovery (Elliott)

<u>ISSUE 2</u>: What are the estimated purchased gas adjustment true-up amounts for the period January 2004 through December 2004?

PGS: \$10,448,229 overrecovery (Elliott)

<u>ISSUE 3</u>: What are the total purchased gas adjustment true-up amounts to be collected or refunded during the period January 2005 through December 2005?

PGS: \$3,179,465 overrecovery (Elliott)

<u>ISSUE 4</u>: What are the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2005 through December 2005?

PGS: \$0.99037 per therm (Elliott)

<u>ISSUE 5</u>: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

PGS: The factor should be effective for all bills from the first billing cycle in

January 2005 through and including the last billing cycle in December 2005. (Elliott)
